MINUTE NUMBER BUSINESS

22/096 APOLOGIES

Apologies were received from Cllr Agutter, Cllr Eldred and Cllr Wilsdon, which were accepted.

22/097 DECLARATIONS OF INTEREST

22/098 CONSIDERATION OF THE MINUTES OF THE MEETING HELD ON 3rd October 2022

22/099 PUBLIC FORUM

A member of the public expressed their frustration that the flooding in the road near the resident's house was still happening. County Councillor Butland was asked to follow up on the situation.

Another resident wanted to express their worries about the proposals for a further solar farm being built opposite their house which would mean the property being surrounded by solar panels.

22/099.1 District & County Councillor Reports:

Dist. Cllr Euesden reported that the footbridge fence at Fentons Road belonged to National Highways and they were in no hurry to fix it as some residents purposely destroy the fence once it is fixed.

BDC have sent out requests to councils for projects to be added to Openspaces planning for the coming year.

CC. Cllr Butland requested information about pot-holes in the area as a 2nd round now can put forward.

ECC are releasing a ± 6.86 m package for food vouchers and the essential living fund.

The council would like to request a grant for new notice board.
